<u>TITLE 5. MATTERS AFFECTING PUBLIC OFFICERS AND EMPLOYEES</u> <u>CHAPTER 176. DISCLOSURE OF CERTAIN RELATIONSHIPS WITH LOCAL GOVERNMENT</u> OFFICERS; PROVIDING PUBLIC ACCESS TO CERTAIN INFORMATION

Sec. 176.003. CONFLICTS DISCLOSURE STATEMENT REQUIRED. (a) A local government officer shall file a conflicts disclosure statement with respect to a vendor if:

(1) the vendor enters into a contract with the local governmental entity or the local governmental entity is considering entering in to a contract with the vendor; and

(2) the vendor:

(A) has an employment or other business relationship with the local government officer or a family member of the officer that results in the officer or family member receiving taxable income, that exceeds \$2,500 during the 12-month period preceding the date that the officer become aware that:

- (i) a contract between the local governmental entity and vendor has been executed; or
- (ii) the local governmental entity is considering entering into a contract with the vendor;

(B) has given to the local government officer or a family member of the officer one or more gifts that have an aggregate value of more than \$100 in the 12-month period preceding the date the officer becomes aware that:

(i) a contract between the local governmental entity and vendor has been executed; or

(ii) the local governmental entity is considering entering into a contract with the vendor; or

(C) has a family relationship with the local government officer.

These seats are normally filled on a three-year rotating basis at the PRPC Annual Meeting. However, given the unexpired term, it is important to ensure that PSA 1 is fully represented on the PRPC Board of Directors. The public meeting to make this appointment by elected officials from PSA 1 may be held digitally by virtue of Texas Government Code Sections 551.127 & 418.016. The seat must be filled by a local elected official (city or county) from Briscoe, Castro, Deaf Smith, Parmer, or Swisher Counties. However, given the unexpired term, it is important to ensure that PSA 3 is fully represented on the PRPC Board of Directors. Collingsworth County Judge John James had held the seat, but sadly the seat now sits vacant. The Planning Commission Bylaws call for this vacancy to be filled by an election of the member cities and counties of the Planning and Service Area. The seat must be filled by a local elected official (city or county) from Childress, Collingsworth, Donley, Gray, Hall or Wheeler Counties. These seats are normally filled on a three-year rotating basis at the PRPC Annual Meeting. However, given the unexpired term, it is important to ensure that PSA 5 is fully represented on the PRPC Board of Directors. The public meeting to make this appointment by elected officials from PSA 5 may be held digitally by virtue of Texas Government Code Sections 551.127 & 418.016. Local government officials from PSA 5 have been notified of this public meeting for the selection of a new PRPC Board

Member. Under this agenda item, a breakout room will be established for PRPC Board Members and representatives of the local governments in PSA 5 to meet independently to select a new Board Member from the service area. At the conclusion of the breakout session, the PSA 5 membership shall present the new Board Member to the PRPC Board of Directors.

PRPC staff recommends that the Board of Directors recognize the new PSA 5 PRPC Board of Directors member, Mayor Dan Sams, brought forth by the PSA 5 membership.

9. PRPC INVESTMENT FUND QUARTERLY REPORT

Mr. Trent Taylor informed the board pursuant to the Public Funds Investment Act which was passed by the Texas Legislature in 1987 and amended in 1995 and 1997, PRPC adopted written investment policies on August 23, 1996 for funds under our control. In accordance with this Act, the investment officer of PRPC, which is the Finance Director, is required to submit to the Board of Directors a quarterly report of investment transactions. The following is a report, which was prepared in compliance with generally accepted accounting principles, of PRPC's portfolio from October 1, 2022 through December 31, 2022.

The money market funds are deposited at Amarillo National Bank. The PRPC fund earned an average annual yield of 3.03% for the quarter. The 9-1-1 fund earned an average annual yield of 2.78% for the quarter. The book value and the market value were the same for each fund listed above. The investment portfolio was in compliance with the Public Funds Investment Act and PRPC Public Funds Investment Policies throughout the quarter. PRPC staff recommends that the Board of Directors accept this report as submitted.

Mayor Buster Davis moved to accept the report. Mayor Kerry Symons seconded the motion; the motion carried by unanimous vote.

10. DISPUTE RESOLUTION CENTER INTERLOCAL COOPERATION CONTRACT FOR ALTERNATIVE DISPUTE RESOLUTION FUNDING PROVIDED IN TEXAS GOVERNMENT CODE 135

Mr. Christian Campbell informed the board as discussed in the last meetings, in accordance with section 135 of the Texas Local Government Code, PRPC is reaching out to the 26 County Courts of the Panhandle to try and establish an interlocal agreement whereby the Dispute Resolution Center (DRC) is agreeable to provide dispute resolution services for the county courts. The County can agree through the use of an interlocal agreement to remit county funds to DRC in accordance with the following sections of the Texas Local Government Code:

135.101: \$213 on filing any civil case except a probate, guardianship, or mental health case. \$35 on any action other than an original action for a case. <u>7.0423%</u> to county dispute resolution fund.

135.102: \$223 on filing any probate, guardianship, or mental health case. \$75 on any action other than an original action for a case. <u>6.7265% to county dispute</u> resolution fund.

135.103: In addition to all other fees and court costs, a person shall pay a local consolidated filing fee of \$33 on filing of any civil case in a justice court. <u>15.1515% to county dispute resolution fund.</u>

Several counties are currently in various stages of adopting the Interlocal Agreement with the Panhandle Dispute Resolution Center to utilize funds allocated for dispute resolution services in accordance with Texas Local Government Code 135. Counties that have passed or are considering this agreement include: Roberts, Deaf Smith, and Briscoe Counties. PRPC staff recommends that the Board of Directors consider favorable approval of the Interlocal Agreement with the above referenced counties in relation to dispute resolution and Texas Government Code 135 by authorizing the Executive Director to execute this document.

Mayor Kerry Symons moved to approve the Interlocal Agreement with the above referenced counties. Mr. Winston Sauls seconded the motion; the motion carried by unanimous vote.

11. PANHANDLE REGIONAL 9-1-1 FY2023 Q1 PERFORMANCE REPORT

Mr. Michael Peters informed the board as stipulated in the agreement between Panhandle Regional Planning Commission and the Commission on State Emergency Communications (CSEC), the Panhandle 9-1-1 Network must establish and accomplish certain goals and objectives. In order to check progress throughout the year, we are required to submit to CSEC a quarterly performance report that includes 9-1-1 call volumes, monitoring results, network outage reports, system testing, and the status of equipment replacement. The following items make up the key points of the FY23 Q1 performance report covering September, October, and November.

- There were 23,888 9-1-1 calls received from the 21 regional call centers of with 18,667 being wireless or 78%.
- Staff monitored eleven Public Service Answering Points (PSAPs) with no findings.
- PSAP staff and PRPC staff performed 962 Network test calls.
- There were two outages during this quarter.
- The region received 1,669 text messages during this period, with the vast majority as test texts.

PRPC staff recommends that the PRPC Board of Directors accept the performance report as submitted for the first quarter of FY 2023 covering September, October, and November.

Dr. Bill Hallerberg moved to accept the performance report as submitted. Judge Ronnie Gordon seconded the motion; the motion carried by unanimous vote.

12. FY2023 REGIONAL SOLID WASTE MANAGEMENT GRANT PROGRAM APPROVAL

Ms. Daphne Morcom informed the board as directed by the Texas Health and Safety Code, a portion of funds collected through landfill "tipping fees" is dedicated to a regional grant program supporting projects that promote recycling and other activities to promote the goals of Regional Solid Waste Management Plans across the state. Every year the Solid Waste Grants Program accepts applications for grant funds and those projects are prioritized according to the priorities established in the Panhandle Regional Solid Waste Management Plan. That prioritized list is then submitted to the TCEQ for final consideration. On December 1, 2022, notices went out to all eligible entities in the region for the FY 2023 Solid Waste Grant cycle. The PRPC received twelve applications totaling \$221,795.68 for the \$112,223.26 in available FY 2023 Solid Waste Grant funds. The Regional Solid Waste Management Advisory Committee (RSWMAC) will meet on January 20, 2023 to review these applications, hear oral presentations from applicants and establish a prioritization recommendation for the Board of Directors to review. The PRPC Board of Directors will consider that prioritized list for approval at the January 26th meeting. That final prioritized list will then be submitted to the Texas Commission on Environmental Quality (TCEQ) for final approval. The list recommended by the RSWMAC for the FY 2023 Solid Waste Grant cycle will be presented at the Board of Director's meeting. PRPC Staff recommends the Board of Directors approve the recommended list of FY 2023 Solid Waste Grant Applications for submission to TCEQ and, pending the TCEQ's approval of the list, allow the Executive Director to enter into contracts with grantees for the implementation of the FY 2023 Solid Waste Grants Program.

Judge Dan Looten moved to approve the recommended list of Solid Waste Grant Application for submission and pending approval. Judge Ronnie Gordon seconded the motion; the motion carried by unanimous vote. Mayor Buster Davis and Mr. Pat Sims abstained from voting.

13. FY2024 JUSTICE ASSISTANCE GRANT PROGRAM APPLICATION RESOLUTION

Ms. Daphne Morcom informed the board each year, the Office of the Governor's Criminal Justice Division (CJD) contracts with PRPC to facilitate the distribution of funds under the following funding blocks for the Panhandle Region:

- Edward Byrne Justice Assistance Grant (JAG)
- Juvenile Justice & Delinquency Prevention Act (JJDP)
- Victims of Crime Act of 1984 (VOCA)
- Violence Against Women Act of 2013 (VAWA)

On December 12, 2022 the Funding Announcement for these funding blocks was sent to all eligible entities. During our January strategic planning meetings, PRPC is consistently told that more cross-training for all stakeholders in the criminal justice system would be beneficial. Some issues have continued to plague the region and continue to come up at strategic planning meetings and in surveys. Those gaps include substance abuse, domestic violence and sexual assault. PRPC staff is proposing to address the training needs through the Specialized Criminal Justice Gap Training Project. This project would orchestrate regional training for professionals involved in law enforcement, courts, prosecution, Judges, dispatchers and victim service agencies. PRPC will contract with Amarillo College's Criminal Justice Department to coordinate the regional training event. Amarillo College will secure professional trainers to address the training needs of the region. PRPC staff recommends that the PRPC Board of Directors favorably consider the attached resolution which authorizes PRPC staff to submit a grant application to the Criminal Justice Division of the Governor's Office under JAG for the Specialized Criminal Justice Gap Training Project.

Judge Ronnie Gordon moved to approve the resolution that authorizes PRPC to submit a grant application to the Criminal Justice Division of the Governor's Office under JAG for the Specialized Criminal Justice Gap Training Project. Dr. Bill Hallerberg seconded the motion; the motion carried by unanimous vote.

14. FY2024-2025 REGIONAL LAW ENFORCEMENT TRAINING ACADEMY GRANT PROGRAM APPLICATION RESOLUTION

Ms. Daphne Morcom informed the board state funds for regional law enforcement training programs are authorized under Section 102.056 of the Texas Code of Criminal Procedure and Section 772.006 of the Texas Government Code. The source of these funds is from monies collected through court costs and fees. The Texas Legislature does not have a specific allocation for law enforcement training academies, typically the State Fund 421 funds have been used to support regional law enforcement training programs. Beginning in 2013 CJD asked Councils of Government to submit a 2-year grant rather than a new program application each year. CJD has continued the request for a 2-year grant since. CJD is accepting applications for law enforcement training grant applications for FY 2024-2025 with a submission deadline of February 9th. PRPC is in the process of drawing up the application for submittal ahead of the deadline.

In reflecting back on recent history, our program funding has remained relatively static for the past nine years. During that timeframe our grant requests have been in the amounts shown below.

In previous years we paid for in-service training on a contract hour basis; since 2015 we have taken a new approach where we pay only the proportion of the class costs equal to the percentage of PRPC-paid officers in each class. This approach has given us the opportunity to provide more training hours with the funds available. With the 2024-2025 Regional Law Enforcement training application, PRPC has been advised by CJD that the funding amount will mirror the FY 2022-2023 contract. The amount for each year of the 2-year grant period will be \$110,543.00. As has been done for the past many years, the 2024-2025 Panhandle Regional Law Enforcement Training Program would include Basic Law Enforcement Training, In-Service Training and Advanced Specialized Training. Every August, in advance of the new school year, PRPC staff will meet with the staff from Amarillo College to negotiate the annual training contract. AC has operated the Panhandle Regional Law Enforcement Training Academy (PRLEA) for over 50 years that it has existed and the contract has to be renewed each year to account for any changes in tuition costs. PRPC staff will present the 2024 PRLEA contract for your consideration later this year at which time we will know how much of a positive impact this funding will have on the level of training services we'll be able to procure in 2024. In order to submit the 2024-2025 grant application to CJD, it must be authorized by the PRPC Board of Directors. Attached for your consideration is a resolution, which if approved by the Board, will allow PRPC staff to continue with the submittal of the grant application to CJD. PRPC staff recommends that the PRPC Board of Directors favorably approve the attached resolution which authorizes PRPC staff to submit a grant application to the Criminal Justice Division of the Governor's Office for the continued operation of the Panhandle Regional Law Enforcement Training Academy for fiscal years 2024 and 2025. The total amount of grant funding requested for the two (2) period is \$221,086.00.

Dr. John Howard moved to approve the resolution that authorizes PRPC to submit a grant application to the Criminal Justice Division of the Governor's Office for the continued operation of the Panhandle Regional Law Enforcement Training Academy for FY2024-2025. Mr. Pat Sims seconded the motion; the motion carried by unanimous vote.

15. FY2024 STATE HOMELAND SECURITY PROGRAM APPLICATION RESOLUTIONS

Ms. Lori Gunn informed the board the FY23 State Homeland Security Program (SHSP) grant application period opened on December 12, 2022. This year's applications are due to the Homeland Security Grants Division of the Governor's Office no later than 5:00 PM on February 9, 2023. The purpose of this grant program is to support local and regional efforts to prevent terrorism and other catastrophic events and to prepare for threats and hazards that pose the greatest risk to public safety. The SHSP plays a significant role in the implementation of the National Preparedness System by providing funding which can be used to build, sustain and deliver core capabilities critical to achieving the National Preparedness Goal of having a secure and resilient Nation. The program has changed rather significantly in the past two years. It used to be that the region would determine how the funds would be used based on an evaluation of needs and priorities. Now, federal spending requirements have to be factored into that determination. In fact, to a certain extent, the federal spending requirements now outweigh the evaluation of needs and priorities. For FY23, in

addition to ensuring that at least 30% of the funding received by the region is spent on Law Enforcement Terrorism Prevention Activities (LETPA); we also have to make sure that at least 3% of the region's FY23 allocation is spent on the first three of the National Priority areas.

- 1. Enhancing Community Preparedness & Resilience (at least 3%);
- 2. Protection of Soft Target/Crowded Places (at least 3%);
- 3. Intelligence and Information Sharing & Analysis (at least 3%);
- 4. Enhancing Cybersecurity (3% under competitive area);
- 5. Combating Domestic Violent Extremism (3% under competitive area); and
- 6. Enhancing Election Security.

What makes meeting these federal funding requirements even more challenging is that we do not know how much funding the Panhandle will receive for FY23 nor will we know that until the projects have been funded. Now, for over 10 years, the PRPC has annually applied for funding to maintain four (4) keystone projects that benefit the entire region. They include:

- 1. The Regional PANCOM Interoperable Public Safety Communications system (which primarily supports the core capability of Operational Communications;
- 2. The Non-EMPG EOP Update Project (which supports the Planning core capability);
- 3. The Panhandle-Area Regional Information System or PARIS (which chiefly serves the core capability of Public Information & Warning); and
- 4. The Regional Planning & Coordination Project (which likewise supports the core capability of Planning).

Over the last two (2) years, we began an effort to update the region's Automated Fingerprint Identification System (AFIS). Using FY21and FY22 funds, we have been in the process of updating the regional AFIS server and equipping four Panhandle LE agencies with new AFIS workstations. In FY23, the PRPC is proposing to equip additional LE agencies with AFIS workstations. Attached for your consideration are resolutions for the five projects being proposed by the PRPC; which with the Board's approval, will be considered for funding under the FY23 SHSP. As has been done in previous years, we are also providing you with a brief description of each proposed project below.

1. FY23 Regional PANCOM Maintenance and Operations

This proposal is for a continuation project. As currently proposed, the project will cover approximately 50% of the annual costs of maintaining the PANCOM system.

2. FY23 Non-EMPG EOP Update Project

This proposal is for a continuation project. This project would provide Emergency Operations planning (EOP) assistance to counties/cities in the

region, which are not receiving Emergency Management Performance Grant (EMPG) funding to support the EOP planning process in FY23.

3. FY23 PARIS Maintenance Project

This proposal is for a continuation project. In 2007, SHSP funds were used to purchase 50 licenses to the Panhandle Area Regional Information System (PARIS) for use by the region's emergency management officials. PARIS is used to support the regional first responder badging program, mutual aid asset inventory and local/regional mass notification capabilities. It has been determined this project will satisfy the National Priority of Protection of Soft Target/Crowded Places.

4. FY23 Regional Planning & Coordination Project

This proposal is for a continuation project. The project is intended to offset the PRPC's costs of administering the regional SHSP program and performing all the planning work required to support the SHSP program in the Panhandle.

5. FY23 Regional AFIS Enhancement: AFIS Workstations Project

This project will equip law enforcement agencies with the workstations they will need to scan/compare crime scene fingerprints and photographs to those maintained in the regional database in search of a match. This project satisfies the National Priority of "Intelligence and Information Sharing/Cooperation".

The deadline for the submission of the FY23 SHSP project applications is February 9th. By approving these resolutions, the Board is not finally approving the funding of these projects. However, you will be asked to consider approving the PREMAC's FY23 SHSP prioritized project list during your meeting in March and these projects will appear on that list. PRPC staff recommends that the PRPC Board of Directors approve the submission of the five regional projects described with this agenda item to the Homeland Security Division of the Governor's Office for consideration under the FY23 State Homeland Security Grant program by the February 9, 2023 submission deadline. If so approved, the Board's consent will have to be documented with the passage of the attached resolutions.

Mr. Pat Sims moved to approve the submission of the five regional projects described to the Homeland Security Division of the Governor's Office for consideration under the FY 2023 State Homeland Security Grant. Mayor Buster Davis seconded the motion; the motion carried by unanimous vote.

16. CHILD CARE PROVIDER CURRICULUM PURCHASE

Ms. Heather Reid informed the board the Texas Workforce Commission (TWC) has contracted with the Panhandle Workforce Development Board (PWDB) / PRPC to utilize Child Care and Development Funds to provide Quality Improvement activities such as technical assistance, professional development and education materials for Texas Panhandle Child Care Providers. The PWDB has tasked its sub-recipient,

Workforce Solutions Panhandle (WSP) with assisting local Child Care Providers who are in the process of obtaining, or raising their current level of, Texas Rising Star (TRS) certification. The TRS program is a quality-based rating system of Child Care Providers participating in TWC's Subsidized Child Care program. TRS certification is available to Licensed and Registered facilities that exceed the State's Minimum Child Care Regulation Standards and meet the certification criteria in such categories as Director and Staff qualifications, caregiver-child interactions, and age-appropriate curricula. State and federal legislation is increasingly underscoring the need for curricula and lesson plans designed to reflect variations in children's needs, skills, and interests in flexible ways. Workforce Development staff has identified our local Child Care Providers' lack of a comprehensive, research-based and validated curricula as a substantial barrier in these Providers' ability to achieve their certification goals. Infant/Toddler and Preschool curriculum kits are available from Teaching Strategies, LLC. Teaching Strategies offers a comprehensive, research-based and validated curricula, which has been distributed to Panhandle Child Care center-based, and home Provider programs, which gives teachers a structural tool that is necessary for creating an intentional and developmentally-oriented structure to classroom instruction, according to TRS guidelines. The PWDB, with PRPC, has made previous purchases of this curricula from Teaching Strategies and proposes to make an additional purchase at this time, for Providers who are working toward initial TRS certification, to give these Providers the benefit of using the same curriculum as currently TRS-certified programs. On August 27, 2020, PRPC board approved an Interlocal Agreement with The Interlocal Purchasing System (TIPS) for PRPC to gain access to the TIPS purchasing contracts. TIPS is a department of the Education Service Center Region 8, and a governmental public entity created by the Texas Legislature, authorized to enter into interlocal agreements with other governmental entities for the purpose of performing governmental functions on behalf of the parties to the interlocal agreement. It conducts competitive procurements with in-house personnel and legal counsel to enable government agencies to make purchases using its purchasing contracts. The purchases for the project described above can be made through the TIPS purchasing process. The total cost for this project is \$147,460.75 and funds for this purchase would come from existing Workforce Development Child Care Quality funds. PRPC staff recommends that the Board authorize the Executive Director to purchase the Child Care Curricula as described above from Teaching Strategies, LLC, for the amount of \$147,460.75, with grant funds from the TWC Workforce Development Child Care Quality grant.

Mayor Kerry Symons moved to authorize the Executive Director to purchase the Child Care Curricula from Teaching Strategies, LLC with grant funds from the TWC Workforce Development Child Care Quality grant. Mayor Buster Davis seconded the motion; the motion carried by unanimous vote.

17. CHILD CARE PROVIDER PRESCHOOL EDUCATIONAL LEARNING MATERIALS

Ms. Heather Reid informed the board as discussed in the previous items, the Texas Workforce Commission (TWC) has contracted with the Panhandle Workforce Development Board (PWDB) / PRPC to utilize Child Care and Development Funds to

provide Quality Improvement activities such as technical assistance, professional development and education materials for Texas Panhandle Child Care Providers. The Panhandle Workforce Development Board has tasked its sub-recipient, Workforce Solutions Panhandle (WSP) with assisting local Child Care Providers who are in the process of obtaining, or raising their current level of, Texas Rising Star (TRS) certification. The TRS program is a quality-based rating system of Child Care Providers participating in TWC's subsidized Child Care program. TRS certification is available to Licensed and Registered facilities that exceed the State's Minimum Child Care Regulation Standards and meets the certification criteria in such categories as Director and Staff qualifications, teacher-child interactions, and indoor/outdoor environments. State and federal legislation is increasingly underscoring the need for educational supports, including learning materials designed to reflect variations in children's needs, skills, and interests in flexible ways. Workforce Development Staff has identified our local Child Care Providers' lack of learning materials that support preschool skills development as a substantial barrier in these Providers' ability to achieve their certification goals. In December 2022, on behalf of Child Care Providers who are in the process of obtaining, or raising their current level of TRS certification, WSP staff researched appropriate preschool educational learning materials in order to purchase educational support for Providers' preschool classrooms. Kaplan Early Learning Company offers a "Little Learners" tablet preloaded with educational learning games that support the acquisition of preschool content skills, including those in STEM (Science, Technology, Engineering, and Math), social/emotional, and language. Child Care teachers can also download additional education learning apps onto the tablet as appropriate. Tablets come in "kid mode" and are designed for Cyber Safety and Security. Products from Kaplan Early Learning Company are available for purchase through The Interlocal Purchasing System (TIPS) purchasing contracts. The total cost for purchasing 460 "Little Learners" tablets is \$147,827.25 and funds for this purchase would come from existing Workforce Development Child Care Quality funds. PRPC staff recommends that the Board authorize the Executive Director to purchase the Child Care Provider "Little Learners" tablets, as described above, from Kaplan Early Learning Company, for \$147,827.25, with grant funds from the TWC Workforce Development Child Care Quality grant.

Judge Dan Looten moved to authorize the Executive Director to purchase the Child Care Provider tablets from Kaplan Early Learning Company with grant funds from the TWC Workforce Development Child Care Quality grant. Mr. Phillip Self seconded the motion; the motion carried by unanimous vote.

18. CHILD CARE OUTDOOR EQUIPMENT AND MATERIALS PURCHASE

Ms. Heather Reid informed the board as discussed in the previous item, the Texas Workforce Commission (TWC) has contracted with the Panhandle Workforce Development Board (PWDB) / PRPC to utilize Child Care and Development Funds to provide Quality Improvement activities such as technical assistance, professional development and education materials for Texas Panhandle Child Care Providers. The PWDB has tasked its sub-recipient, Workforce Solutions Panhandle (WSP) with assisting local Child Care Providers who are in the process of obtaining, or raising their current level of, Texas Rising Star (TRS) certification. The TRS program is a quality-

based rating system of Child Care Providers participating in TWC's Subsidized Child Care program. TRS certification is available to Licensed and Registered facilities that exceed the State's Minimum Child Care Regulation Standards and meet the certification criteria in such categories as Director and Staff qualifications, teacher-child interactions, and indoor/outdoor environments. Workforce Development staff has elected to purchase outdoor learning materials and equipment in order to assist Providers in reaching TRS standards for outdoor environments. The equipment chosen was based on feedback from TRS Mentoring staff and previous assessment results related to outdoor learning environments. Beginning in December 2022, on behalf of Child Care Providers who are working towards TRS certification, WSP staff researched age-appropriate outdoor learning materials and equipment. Kaplan Early Learning Company was selected as the vendor for this project due to the appropriate outdoor learning materials and equipment. The appropriate outdoor learning materials and equipment that they had available compared to other companies. The materials and equipment that were selected for purchase were divided into three "kits" according to the ages of the children served at each Provider.

Kits 1 with separate components including:

- Talladega Pedal Path
- Balance Bike Set of 2
- Trike Set of 2
- Safety Helmet 4 each

Total Cost: \$42,130.88

Kits 2 with separate components including:

- Infant Corral
- Create and Explore Learning Kit for Mobile Infants & Toddlers Total Cost: \$75,000

Kits 3 with separate components including:

- Discovery Station Doctor's Office
- Doctor Set with Bag 4 each

Total Cost: \$18,989.48

Products from Kaplan Early Learning Company are available for purchase through The Interlocal Purchasing System (TIPS) purchasing contracts. The total cost for this project is estimated to be \$136,120.36 and funds for this purchase would come from existing Workforce Development Child Care Quality funds. PRPC staff recommends that the Board authorize the Executive Director to purchase the Child Care Provider outdoor learning kits as described above from Kaplan Early Learning Company, for not more than \$136,120.36, with grant funds from the TWC Workforce Development Child Care Quality grant.

Judge Dan Looten moved to authorize the Executive Director to purchase the Child Care Provider outdoor learning kits from Kaplan Early Learning Company with grant funds from the TWC Workforce Development Child Care Quality grant. Mr. Winston Sauls seconded the motion; the motion carried by unanimous vote.

19 DOWNTOWN REVITALIZATION APPLICATION DEVELOPMENT AND MANAGEMENT SERVICES INTERLOCAL CONTRACTS

Ms. Paige Goodell informed the board PRPC Staff has worked with Panhandle communities to write applications and implement various projects through the Community Development Block Grant (TxCDBG) Program since 1983. Through the CDBG program the Texas Department of Agriculture (TDA) offers many different funding opportunities that include: Community Development Fund Program; Fire, Ambulance, and Service Truck (FAST) Fund; State Urgent Need (SUN) disaster relief and the Downtown Revitalization Program. The Downtown Revitalization Program stated objectives are for the elimination of slum or blight conditions in the downtown areas of communities by providing assistance for public infrastructure improvements, especially sidewalks and ADA compliance. There are several cities that have already expressed interest in preparing an application to seek to improve the blighted conditions through infrastructure improvements in their downtown areas. Following the format that has become the new standard for TxCDBG applications; an interlocal agreement has been developed for PRPC to assist communities with an application to the Downtown Revitalization Program. In order to comply with TDA requirements as well as maintain the long-established tradition of conducting application development at no charge to communities in the region, the interlocal agreement is two parts:

Part 1 - Application development will be conducted at no cost.

Part 2 - An option for an Amendment to be consider contingent upon funding for Project Management Services.

Historically, these are all activities conducted by PRPC Staff on projects and applications. However, in order to comply with TDA requirements it is necessary for the below cities to enter into an interlocal agreement with PRPC for application development activities to ensure programmatic compliance. Cities applying to the Downtown Revitalization program for 2023 are the Cities of Clarendon and Pampa. PRPC staff recommends that the Board of Directors authorize the Executive Director of the PRPC to execute an Interlocal Cooperation Contract between the above noted communities respectively and the PRPC to provide TxCDBG Downtown Revitalization application services at no cost with contingency for administrative services to be amended at the localities' discretion if their project is funded.

Mayor Kerry Symons moved to authorize the Executive Director to execute an Interlocal Cooperation Contract between the above noted communities and the PRPC to provide TxCDBG Downtown Revitalization application services at no cost with contingency for administrative services to be amend at the localities' discretion if their project is funded. Mr. Phillip Self seconded the motion; the motion carried by unanimous vote.

20. TEXAS COMMUNITY DEVELOPMENT PROGRAM APPLICATION DEVELOPMENT AND MANAGEMENT SERVICES INTERLOCAL CONTRACTS

Ms. Paige Goodell informed the board PRPC Staff has worked with Panhandle Communities to implement infrastructure improvement projects through the Community Development Block Grant (TxCDBG) Program since 1983. Since that time, PRPC Staff has provided administrative assistance on over 330 TxCDBG projects totaling more than \$80,000,000 of grant funds utilized for the infrastructure improvement of Panhandle Communities. The Texas Department of Agriculture (TDA),

has long been the funding agency of this program in the State of Texas, and they are in the process of soliciting applications for the 2023/2024 TxCDBG program. Following the format established during the TxCDBG application process conducted in the Fall of 2017, an interlocal agreement has been developed for PRPC to assist communities interested in developing applications to Texas Department of Agriculture programs particularly under the Community Development Block Grant umbrella. In order to comply with TDA programmatic requirements as well as maintain the long-established tradition of conducting application preparation at no charge to communities in the region, a non-cost interlocal agreement has been developed for application development activities. The interlocal agreement will easily allow for an optional amendment to be considered upon notice of award that will allow PRPC to provide the project management services if so desired by the applicant. In anticipation of PRPC Staff preparing approximately 15 TxCDBG applications this cycle, Staff has determined that it would be necessary for the Board to consider the Interlocals associated with the application preparation in multiple groupings for two reasons. 1. There is a staggering of the public hearings and meetings that Staff goes to chronologically to ensure that Staff can be in each community during an application cycle. 2. With over 15 entities applying there could be a problem with Board voting membership having to recuse themselves if all projects were presented together.

To this end, the following interlocal agreements are being presented to the Board in January of 2023:

- a. Clarendon
- b. Turkey
- c. Higgins
- d. Texline
- e. Quitaque
- f. Cactus
- g. Collingsworth County

Each of these is a no-cost interlocal agreement between PRPC and the respective entity for the preparation of a 2023-24 TxCDBG application with a project administration section contingent upon future funding with details to be amended in later. The focus of these interlocals is to allow PRPC to continue providing the same services as in previous cycles and meet TDA's requirements to establish formal relationships prior to the submission of applications PRPC staff recommends that the Board of Directors authorize the Executive Director of the PRPC to execute an Interlocal Cooperation Contract with the above-mentioned communities respectively and the PRPC to provide TxCDBG application services at no cost with contingency for administrative services to be amended at the localities discretion if a project is funded.

Mr. Winston Sauls moved to authorize the Executive Director to execute an Interlocal Cooperation Contract with the above-mentioned communities and the PRPC to provide TxCDBG application services at no cost with the contingency for administrative services to be amended at the localities discretion if a project is funded. Mayor Buster Davis seconded the motion; the motion carried by unanimous vote.

21. TEXAS COMMUNITY DEVELOPMENT PROGRAM AGREEMENT AMENDMENT FOR THE 2023 DOWNTOWN REVITALIZATION/MAIN STREET PROGRAM INTERLOCAL CONTRACTS

Mr. Alex Guerrero informed the board that The Community Development Block Grant program administered by the Texas Department of Agriculture (TDA) offers many different funding opportunities for communities in the Texas Panhandle for over 40 years. Since that time, PRPC has worked with cities, counties, water supply corporations and special districts to develop applications for funding assistance and bring much needed grant dollars to their local communities. The programs offered through CDBG funding have included the: Community Development Fund Program; Fire, Ambulance, and Service Truck (FAST Fund) Program; State Urgent Need (SUN) disaster relief; and the Downtown Revitalization/Main Street Set-Aside Program. The Downtown Revitalization/Main Street Set-Aside Program stated objectives are for the elimination of slum or blight conditions in the downtown areas of communities by providing assistance for public infrastructure improvements, specifically sidewalks and ADA compliance. This past year PRPC worked with several communities to develop and submit applications to this program. Out of the six Texas Panhandle communities that applied in July 2022, the Cities of Childress and Gruver have received indications from Texas Department of Agriculture that the agency will be issuing each a grant award through the TxCDBG Downtown Revitalization/Main Street Set-Aside program with an increase in funding from past program years of \$350,000 to \$500,000. In April 2022, this body approved a no-cost interlocal agreement that allowed PRPC to assist each of the above-mentioned cities to develop applications to the Downtown Revitalization/Main Street Set-Aside Program. This agenda item is to amend the interlocal agreements between PRPC and each of these cities to allow PRPC to carry out the administrative function and project management activities associated with the funded project. The Cities of Childress and Gruver will each receive \$500,000 in grant funds to make necessary improvements in their Downtown and Main Street area and the project management fee was set at a flat rate of \$40,000 for each project to perform the administrative and project management function. PRPC staff recommends that the Board of Directors authorize the Executive Director of the PRPC to execute an amendment to the Interlocal Cooperation Contracts between the Cities of Childress and Gruver and the PRPC to provide administration services for the Downtown Revitalization Program.

Mayor Kerry Symons moved to authorize the Executive Director to execute an amendment to the Interlocal Cooperation Contracts between the cities of Childress and Gruver and the PRPC to provide administration services for the Downtown Revitalization Program. Mr. Winston Sauls seconded the motion; the motion carried by unanimous vote.

22.<u>TEXAS COMMUNITY DEVELOPMENT PROGRAM AGREEMENT AMENDMENT</u> <u>DEVELOPMENT AND MANAGEMENT SERVICES INTERLOCAL CONTRACTS</u>

Mr. Alex Guerrero informed the board the Texas Department of Agriculture (TDA) has long been the funding agency for the Community Development Block Grant (CDBG) Program in the State of Texas. In late 2020 and early 2021, TDA solicited applications to the 2021/2022 TxCDBG program and PRPC assisted over 20 communities in the Panhandle to write, develop and submit applications to this long-standing program for basic water and sewer infrastructure improvements. This body passed no-cost interlocal agreements for application development for each of these communities in order to comply with TDA requirements pertaining to procurement. The no-cost interlocal agreement is to maintain the long-standing history of providing application development at no cost to Panhandle communities. However, this interlocal agreement is designed to be easily amended contingent upon funding for project management services. In 2021, PRPC received notification that the top seven scoring panhandle communities would be receiving a TDA contract for TxCDBG funds in the program year of 2021. For program year of 2022, PRPC received notification that twelve of the panhandle communities would be receiving a TDA contract for TxCDBG funds totaling to almost the entirety of the applications submitted for the 2021/2022 Community Development Cycle. The below list is subject to change as the funding agency, TDA, prepares projects for funding. This agenda item is to allow for the authorization of the Interlocal Amendment to carry out the administrative function and project management activities should the below projects receive grant funding. These activities are outlined in detail in the attached sample amendment and consist of:

- Project Management
- Financial Management
- Environmental Review
- Acquisition
- Construction Management
- Fair Housing/Equal Opportunity
- Audit/Close-out Procedures

The funds from the TxCDBG grants will assist the below communities to make necessary improvements to their water, sewer and road infrastructure services. Below is a list of the remaining communities that are likely to receive a grant award. This list includes: project type, amount of TxCDBG funding, the match amount committed by each community, and the amount that will be paid to the PRPC for general administration functions associated with the grant.

BACKGROUND

As discussed in the last meetings, in accordance with section 135 of the Texas Local Government Code, PRPC is reaching out to the 26 County Courts of the Panhandle to try and establish an interlocal agreement whereby the Dispute Resolution Center (DRC) is agreeable to provide dispute resolution services for the county courts. The County can agree through the use of an interlocal agreement to remit county funds to DRC in accordance with the following sections of the Texas Local Government Code:

135.101: \$213 on filing any civil case except a probate, guardianship, or mental health case. \$35 on any action other than an original action for a case. <u>7.0423% to county dispute resolution fund.</u>

135.102: \$223 on filing any probate, guardianship, or mental health case. \$75 on any action other than an original action for a case. <u>6.7265% to county dispute</u> resolution fund.

135.103: In addition to all other fees and court costs, a person shall pay a local consolidated filing fee of \$33 on filing of any civil case in a justice court. <u>15.1515% to county dispute resolution fund.</u>

Several counties are currently in various stages of adopting the Interlocal Agreement with the Panhandle Dispute Resolution Center to utilize funds allocated for dispute resolution services in accordance with Texas Local Government Code 135. Counties that have passed or are considering this agreement include: Dallam Counties.

RECOMMENDATION

Staff recommends that the Board of Directors consider favorable approval of the Interlocal Agreement with the above referenced counties in relation to dispute resolution and Texas Government Code 135 by authorizing the Executive Director to execute this document.

AGREEMENT FOR SERVICES

WHEREAS, this Contract is made and entered into this the _____ day of ______ by and between the County of ______, acting by its duly authorized representative, after obtaining a resolution of its governing body authorizing this contract and the PANHANDLE REGIONAL PLANNING COMMISSION (PRPC), a political subdivision of the State of Texas organized under Chapter 391 of the Texas Local Government Code, acting by its duly authorized executive director.

WHEREAS, both parties to this Contract are local governments as defined in Chapter 791 of the Texas Government Code, and this Contract is entered into pursuant to the provisions of said Code which is commonly referred to as The Interlocal Cooperation Act.

WHEREAS, PRPC is agreeable to provide dispute resolution services for the county courts. This service will be provided by the Dispute Resolution Center (DRC) at the Panhandle Regional Planning Commission under the normal fee structure. Dispute resolutions may be held in the county, via Zoom or in the PRPC offices.

WHEREAS, the County of ______ agrees to set aside county funds under Texas Local Government Code 135. The statue sets aside the following funds to be remitted to the Panhandle DRC:

135.101: \$213 on filing any civil case except a probate, guardianship, or mental health case. \$35 on any action other than an original action for a case. <u>7.0423% to county dispute resolution fund.</u>

135.102: \$223 on filing any probate, guardianship, or mental health case. \$75 on any action other than an original action for a case. <u>6.7265% to county dispute resolution fund.</u>

135.103: In addition to all other fees and court costs, a person shall pay a local consolidated filing fee of \$33 on filing of any civil case in a justice court. <u>15.1515% to county dispute resolution fund.</u>

Additionally, Section 135.157 subsection A describes how a county may use these percentages to create a fund for an alternative dispute resolution system (A.D.R.). Subsection B states that, "If a county has not established an A.D.R. system... the money allocated under subsection A shall be remitted to the comptroller and the comptroller shall allocate the money to the statewide electronic filing system fund". Therefore, if these funds are not designated to an alternative dispute resolution system as being described in this agreement with the Panhandle DRC, they must be sent to Austin for inclusion in the statewide electronic filing system fund.

TERMS AND CONDITIONS

Modification/Amendment:

The County of ______ and PRPC may, upon mutual agreement, modify or amend this contract. Modifications, including any increase or decrease in the amount of compensation or scope of services, will be incorporated into this contract and finalized through a signed, written amendment.

Assignability:

The County of ______ and PRPC may assign interest in this Contract (whether by assignment or novation) with the written consent of the other.

Termination of Contract for Cause:

If, through any cause, PRPC shall fail to fulfill in a timely and proper manner its obligations under this Contract, or if PRPC shall violate any of the covenants, conditions, agreements, or stipulations of this Contract, the County shall thereupon have the right to terminate this Contract by giving written notice to PRPC of such termination and specifying the effective date thereof, at least five days before the effective date of such termination.

Notwithstanding the above, PRPC shall not be relieved of liability to the County for damages sustained by the County by virtue of any breach of the Contract by PRPC, and the County may withhold any payments to PRPC for the purpose of set off until such time as the exact amount of damages due the County from PRPC is determined.

Termination for Convenience of the City/County:

The County may terminate this Contract at any time by giving at least ten (10) days notice in writing to PRPC.

Termination for Convenience of PRPC:

PRPC may terminate this Contract at any time by giving at least ten (10) days notice in writing to the City/County.

Severability

Should any one or more of the provisions of this agreement be held to be null, void, voidable, or for any reason whatsoever, of no force and effect, such provision(s) shall be construed as severable from the remainder of this agreement and shall not affect the validity of all other provisions of this agreement, which shall remain in full force and effect.

BACKGROUND

On August 25th 2022, the PRPC Board voted to continue to operate DRC with matrix and financial goals being met. I am pleased to say we are on track and moving forward. Attached are the Financials for October through January. Our loss for the year ending 9/30/22 was \$35,289.13. As you can see, we have a positive bottom line for the current year and expect it to only get better. In addition, we have provided the following stats:

Mediations held since March 2022: 182 # of referrals: 194 Reached agreement: 108 cases (55.7%) Substantially Settled Through Mediation (SSTM): 10 cases (5.2%) No Agreement: 44 cases (22.6%) Canceled or No Show: 32 cases (16.5%)

Zoom mediations: 114 cases (62.4%) In person mediations, including travel: 68 cases (37.6%)

Family Law: 171 cases (88.2%) Other civil: 23 cases (11.8%) Pre-pleas: 31 cases

Hours mediated: 264.75 total hours, 110.5 volunteer hours. Volunteers have conducted 41.74% of mediations April 2022-Dec 2022

As we wind down getting Interlocal agreements with the counties, our next push will be educating the Panhandle about the DRC in hopes of increasing the number of mediations we are handling. We will keep you posted with updates in the future.

SUBJECT: Agenda Item 9: Interlocal Cooperation Contract for Sub-contractual services with the South Plains Association of Governments for the PRPC Regional Infrastructure Accelerator Program

BACKGROUND

In April 2022, LGS staff prepared an application to the Build America Bureau's 2022 Regional Infrastructure Accelerator (RIA) Program. The Build America Bureau has been in operation since 2016 and is affiliated with the US Department of Transportation. This program was established as part of the Fixing America's Surface Transportation (FAST) Act and is focused on providing technical assistance to cities, counties, special districts, and other entities to rehabilitate and repair surface transportation facilities. Facilities include county roads, municipal roads, non-TxDOT owned bridges, etc.

PRPC would be committing to provide technical assistance in the form of environmental reviews, engineering procurement, planning studies, and preparation of applications to funding programs. Staff has coordinated a partnership with the South Plains Association of Governments (SPAG) in order to expand the boundaries of this regional program. PRPC has successfully collaborated with these regions in the past in revolving loan programs, economic development, and transportation. Expanding the region to include 46 counties will provide better opportunities for cross-region collaboration on projects, possible project bundling opportunities, and better success of projects for funding.

In August 2022, the PRPC was selected out of 1 in 5 agencies in a nation-wide competition to establish an RIA program in the Panhandle and South Plains regions of Texas. The Federal Highway Administration (FHWA) has been assigned to administer the funding of this program over the next two years in the amount of \$454,852.00 with no matching requirement from the grant recipient. This agenda item is an Interlocal Sub-Cooperative Contract for \$50,000.00 dedicated to contractual services with SPAG for their partnership with the RIA program to provide information and assistance in the Lubbock region.

RECOMMENDATION:

PRPC staff recommends that the Board of Directors authorize the Executive Director of the PRPC to execute an interlocal sub-cooperation contract to partner with the South Plains Association of Governments for the PRPC Regional Infrastructure Accelerator Program.

WHEREAS, this Contract is made and entered into this the <u>23rd</u> day <u>of February</u>, 2023 by and between the PANHANDLE REGIONAL PLANNING COMMISSION (PRPC) (Consultant), a political subdivision of the State of Texas organized under Chapter 391 of the Texas Local Government Code, acting by its duly authorized Executive Director; and, after obtaining approval of its governing body authorizing this contract and the SOUTH PLAINS ASSOCIATION OF GOVERNMENTS (SPAG), a political subdivision of the State of Texas organized under Chapter 391 of the Texas Local Government Code, acting by its duly authorized Executive Director; and, after obtaining approval of the State of Texas organized under Chapter 391 of the Texas Local Government Code, acting by its duly authorized Executive Director; and,

WHEREAS, both parties to this Contract are local governments as defined in Chapter 791 of the Texas Government Code, and this Contract is entered into pursuant to the provisions of said Code which is commonly referred to as The Interlocal Cooperation Act; and,

WHEREAS, SPAG is agreeable to act as a subcontract consultant for providing services and professional expertise needed by the Panhandle Regional Planning Commission to assist PRPC in the implementation of its stated mission under the following terms and conditions:

WHEREAS, SPAG is agreeable to assisting the Panhandle Regional Planning Commission by providing the PRPC with the professional services and institutional resources necessary to serve as the designated Consultant. In consideration of SPAG providing professional services for PRPC and PRPC utilizing SPAG's services on an independent contractor basis; the parties hereby agree:

- 1. SPAG will provide PRPC with the services described in the 'Scope of Services.'
- 2. SPAG will provide any and all tools, supplies, office space, and transportation needed to provide these services.
- 3. PRPC will pay SPAG on the basis and under the conditions described in 'Compensation.'
- 4. This Agreement for professional services may be terminated in accordance with the conditions described in the 'Termination Clause.'

NOW, THEREFORE SPAG agrees to provide the following described professional services to the Panhandle Regional Planning Commission:

SCOPE OF SERVICES

The services provided under this contract constitute a portion of the scope of services necessary for Program Implementation Services for the PRPC Regional Infrastructure Accelerator (RIA) Grant awarded on January 9, 2023. The Consultant will work together with PRPC and the Federal Highway Administration (FHWA) to assist in the performance of the following services and provide professional expertise on the subject matter. The general activities and basic services to be provided by SPAG include the following:

- A. Program Implementation Services:
 - 1. Perform routine administrative tasks and correspondence.
 - 2. Serve as a liaison for the South Plains region.
 - 3. General Personnel Management Services.
 - 4. Assist with planning regional events between SPAG and PRPC.

- 5. Attendance for hosted regional events.
- 6. Assist with the information needed for quarterly reporting for the duration of the grant.
- 7. Outreach for potential projects for the RIA program.
- 8. Assist in selecting a committee RIA program for both SPAG and PRPC regions.
- 9. Collaborate with PRPC to create a successful program for this RIA grant.

TIME OF PERFORMANCE

The SPAG agrees to provide the services described in the foregoing paragraphs for a period of two (2) years from the date of execution of this contract. The time commitment from the SPAG will be on a needed basis per week/month as determined by PRPC, for a total of two (2) years.

COMPENSATION

In consideration of the services described in the foregoing paragraphs to be rendered by PRPC to the South Plains Association of Governments, the Panhandle Regional Planning Commission agrees to make the following payment to the SPAG:

- 1. Total Compensation for the 2-Year Contract shall be \$50,000.00.
- 2. PRPC shall invoice and provide reimbursement on a quarterly basis until the end of the contract duration as described in the supplemental budget documentation for the RIA contract.

TERMINATION CLAUSE

The SPAG and the PRPC enter into this agreement with the understanding that the contract will remain in full force and effect for the duration of the two (2) year period specified in Section II TIME OF PERFORMANCE. However, either the SPAG or the PRPC may terminate this contract in its entirety by providing the other party written notice of termination thirty (30) days prior to the effective date of termination. Payment will be on a pro-rata basis up to the date of termination of this contract. The SPAG shall deliver to the PRPC all products, reports, and working documents developed on behalf of the SPAG prior to the termination date.

GENERAL PROVISIONS

It is expressly understood and agreed by the parties hereto that they are independent contractors; and that nothing contained herein should be construed as giving rise to a partnership or joint venture.

SPAG shall maintain fiscal records and supporting documentation for all expenditures of funds made under this Contract in a manner that conforms to OMB Circular A-87, the Management Standards, and this Contract. SPAG agrees to comply with the retention and custodial requirements for records as set forth in Attachment C of OMB Circular A-102, as supplemented by Section 5.154 of the Management Standards.

SPAG shall give the Comptroller General of the United States, the Auditor of the State of Texas, the auditor of the South Plains Association of Governments and Panhandle Regional Planning Commission, or any of their duly authorized representatives, access to and the right to examine all books, accounts, records, reports, files, and other papers, things, or property belonging to or in use by SPAG or pertaining to this Contract. Such rights to access shall continue as long as the records are retained by SPAG and PRPC agrees to maintain such records in an accessible location.

SPAG shall fully comply with all relevant provisions of: Equal Employment Opportunity laws, the Civil Rights Act of 1964, Section 109 of the Housing and Community Development Act, and Section 3 requirements regarding employment, training, and business opportunities.

SPAG and no official or employee thereof shall have any personal financial interest, direct or indirect, in this Contract; and SPAG shall take steps to assure compliance.

SUBJECT: Agenda Item 11: Fair Housing Month Proclamation

BACKGROUND

The Panhandle Regional Planning Commission (PRPC) is under contract with the Texas Department of Agriculture to provide community and economic planning activities for the Texas Panhandle. Through the Community and Economic Development Assistance Fund (CEDAF) contract, PRPC receives a grant to provide technical assistance to communities in the Panhandle regarding community and economic development programs.

Under the requirements of the contract, PRPC is required to conduct a Fair Housing Activity in the region. Title VIII of the Civil Rights Act of 1968, The Fair Housing Act, prohibits discrimination in the sale or rental of units in the private housing market against any person on the basis of race, color, religion, sex, national origin, age, physical/mental handicap, or familial status (i.e. children under 18) and provides for relief including the award of monetary damages where discriminatory housing practices are found.

The attached proclamation will fulfill PRPC's requirement to conduct a Fair Housing Activity and will raise the awareness of the importance of equal housing opportunities in the Panhandle.

RECOMMENDATION

Staff recommends that the Board of Directors adopt the Fair Housing Proclamation, which designates March 2023 as Fair Housing Month and encourages equal housing opportunity to all citizens of the Panhandle.

Proclamation of March 2023 As Fair Housing Month

WHEREAS, *Title VIII of the Civil Rights Act of 1968*, as amended, prohibits discrimination in housing and declares it a national policy to provide, within constitutional limits, fair housing in the United States; and

WHEREAS, while the principles of *Fair Housing* are a matter of national policy and law, *Fair Housing* is also a basic human concept that provides fairness in equal housing opportunity to citizens of the United States; and,

WHEREAS, recognizing February as *Fair Housing Month* provides an opportunity for citizens to be aware that achieving success in equal housing opportunity is accomplished with the help and cooperation of all citizens.

NOW, THEREFORE, WE HEREBY PROCLAIM the month of March 2023, as *Fair Housing Month* in the Panhandle region of the State of Texas and do hereby urge all the citizens of this region to become aware of and support *Fair Housing*.

BACKGROUND

On January 19, 2023, members of various organizations from across the Panhandle gathered in Borger at the Dome Civic and Convention Center to participate in a full day of discussion on the response and recovery aspects of a mass casualty attack in the Panhandle.

This workshop was developed by the Texas Department of Public Safety, Office of Homeland Security with help from a local planning team with members from Oldham, Carson, Hutchinson, Gray, Dallam, and Hartley Counties, as well as the Texas Division of Emergency Management, Texas Department of State Health Services, Panhandle RAC, and our regional 2-1-1 network. This workshop scenario was based on the annual XIT Rodeo in Dalhart, but the planning team was able to make the exercise versatile so that participants across the region could apply the key takeaways to their local events as well. In total, we had over 80 organizations and 160 people attend this workshop.

The scenario the workshop focused on was an active shooter event during the Saturday night concert at the XIT Rodeo with an additional IED located nearby as a secondary event. There were three breakout groups that discussed various aspects of an incident of this nature: Operational Coordination, Emergency Medical Response and Hospital Operations, and Public Information, Family Reunification, and Recovery Operations. Participants were divided by disciplines into these three groups so they could focus on the specific aspects of the response and recovery that most applied to their agency/position.

Before the participants broke out into their smaller groups, the Potter County Sheriff's Office gave an excellent presentation on the Tri-State Fair Shooting Incident. Sheriff Thomas brought in several officers involved in the response to that event, and they discussed lessons learned and how they are working with the Tri-State Fair to plan for next year.

SUBJECT: Agenda Item 13: FY23 State Homeland Security Grant Program Purchase Authorization and Equipment Distribution Approvals

BACKGROUND

The purpose of this agenda item is two-fold. First, PRPC staff is requesting Board authorization to issue purchase orders for new Automated Fingerprint Identification System (AFIS) equipment and software which is being paid for with funding we've received under an FY23 State Homeland Security Program (SHSP) grant. Second, the Board is being asked to consider the Panhandle Regional Emergency Management Advisory Committee's (PREMAC) recommendations concerning the agencies that should receive this new AFIS equipment and software.

AFIS is a law enforcement tool used to match fingerprints to people. It automates the otherwise time-intensive task of manually processing fingerprints taken from crime suspects or crime scenes. It is a powerful and effective investigative tool capable of quickly sifting through large fingerprint databases to produce a relevant candidate list of potential matches.

In 2006, the Panhandle implemented its first regional AFIS program. That project resulted in the creation of a regional fingerprint database; built specifically to house prints taken from individuals who'd been arrested in the Panhandle or lifted from crime scenes in the region. Additionally, all 26 County Sheriff's Offices received an AFIS workstation.

By 2015, the original AFIS workstations had grown obsolete and had to be replaced; once again using SHSP funding to cover the cost. However, with this second iteration of the regional AFIS program, only those agencies that had or planned to have a trained fingerprint examiner on staff received a new workstation. In turn, agencies receiving new workstations committed to helping their neighboring agencies that did not.

Every jail in the region has a Live Scan device that's used to collect prints and photographs from arrestees at the time they're being booked. Those prints are then submitted to the State's fingerprint database maintained by DPS. Simultaneously, they're being deposited into the regional AFIS database housed at the City of Amarillo.

The benefit of using a dual submit process for fingerprint entry is that it's much faster to search for a match on the regional database than it is to search the DPS database. AFIS has the ability to do both but while the regional database holds around 450,000 sets of prints; the DPS database houses many million more. There's a pretty good chance that when latent prints are found on a Panhandle crime scene that someone from the region committed the crime. And, if it wasn't their first offense, odds are, their prints are already in the regional database.

The workstations are essentially where the comparison and matching of fingerprints occur. A trained fingerprint examiner will scan a set of prints found at a crime scene or taken from a suspect and the AFIS software will then sort through the regional database and bring up a candidate list of prints that come closest to matching the examiner's set. The examiner must then determine if the crime scene/suspect's prints are among those on the candidate list. If not, the examiner can then extend the search into the DPS database. With the upgraded software being installed with the PRPC's FY23 AFIS Upgrade project, the workstations can also be used to match pictures (from security cameras, etc.) against arrestee photos stored in the databases.

Many of our law enforcement agencies report that since they've started using the AFIS; they've been able to close cases that have been cold for decades. Their normal case closure rates have also increased significantly. However, the AFIS is simply a piece of equipment. The secret to a good AFIS program is having a staff of well-trained fingerprint examiners that can visually correspond and match crime scene prints to a set found in the database.

In 2022, the region's began replacing old, outdated workstations with new AFIS technology that included facial recognition software integrated along with the ability to search on fingerprint whirls and ridgelines to dramatically enhance the value of AFIS. With this new generation of software, fingerprint examiners will be able to process multiple complex biometric transactions with high accuracy and link face recognition to fingerprints.

With regard to the first purpose of this item, SPEX Forensics, located in Edison, NJ, is the sole proprietor of the PrintQuest AFIS system on which the regional AFIS database and the AFIS workstations rely. We've been working with SPEX since the initial installation of the region's AFIS system in 2005. That year, the PRPC went through an extensive procurement process to determine which make/model of AFIS would best serve the region's needs. The SPEX equipment was deemed to be the "*lowest/best*" of all the equipment proposed and evaluated.

SPEX equipment was used to create the 26-county AFIS system and it's also being used to support the operation of the regional database. So, from point-to-point, the entire regional system has been built on SPEX equipment.

Since each AFIS manufacturer uses proprietary software, it's not possible to mix & match AFIS makes/models; the equipment is not interoperable. The point being is because of the decisions made back in 2005; our wagon will remain hitched to SPEX whenever AFIS equipment has to be replaced. That's not a bad thing; SPEX has been nothing but a valued partner in ensuring the reliability of our regional AFIS system.

I point this out simply to confirm the legitimacy of this purchase as it applies to the PRPC purchasing policies. At this point, the only way we could purchase workstations other than those manufactured by SPEX would be to completely scrap the current system and rebuild using some other vendor's system.

Previously, when upgrading the AFIS equipment; we'd purchase both the equipment and software from SPEX. However, with this new generation of AFIS, as a cost-savings measure, we'll be able to overlay the upgraded SPEX software onto ordinary computer equipment. So, in our FY23 AFIS Update SHSP grant applications, PRPC staff proposed to buy the software and licenses from SPEX and to purchase the equipment off the Department of Information Resources (DIR) State contract.

In order to complete the project; PRPC will need to purchase the equipment shown on the tables below:

The PREMAC considered locations for the new workstations at their last meeting in December and is recommending that Canyon Police Department, Deaf Smith County Sheriff's Office, Dumas Police Department, Pampa Police Department and Ochiltree County Sheriff's Office each receive one new workstation.

If this recommendation is approved, the PRPC staff will develop agreements to transfer ownership of the equipment and software over to Canyon PD, Deaf Smith SO, Dumas PD, Pampa PD and Ochiltree SO once it has been purchased and properly installed.

RECOMMENDATION:

PRPC staff recommends the following that:

- a) The PRPC Board of Directors authorize PRPC staff to issue a purchase order to SPEX Forensics for the software and related services (installation) needed to complete the PRPC's State Homeland Security Program (SHSP)-funded FY23 AFIS Upgrade projects.
- b) The PRPC Board of Directors authorize PRPC staff to proceed with the purchase of the computer equipment needed to complete the PRPC's SHSP-funded FY23 AFIS Upgrade projects utilizing the DIR State contracts.
- c) That the PRPC Board of Directors approve the distribution of new workstations to the Canyon Police Department, Deaf Smith County Sheriff's Office, Dumas Police Department, Pampa Police Department and Ochiltree County Sheriff's Office.


